PLEDGE OF ALLEGIANCE AND PRAYER

At this time, the Pledge of Allegiance was recited. A prayer followed the pledge.

MINUTES

Motion by Councilmember Brewer second by Councilmember Briggs that the minutes of July 25, 2022, be approved. Motion carried.

BILLS

Motion by Councilmember Brewer second by Councilmember Briggs that all duly obligated bills for the city be paid. Motion carried.

REPORTS

Reports were given by Councilmember Briggs, City Administrator Urton and Mayor Crooks.

BILL NO. 33

Motion by Councilmember Brewer second by Councilmember Briggs that Bill No. 33 be introduced, AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING A VOLUME COMMITMENT AGREEMENT BY AND BETWEEN THE CITY OF TRENTON, MISSOURI, AND ARKANSAS ELECTRIC COOPERATIVES, INC. BETWEEN THE CITY OF TRENTON AND ARKANSAS ELECTRIC COOPERATIVES, INC., IN THE CITY OF TRENTON AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY, which was read. Motion by Councilmember Brewer second by Councilmember Briggs that Bill No. 34 be introduced, AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING A SERVICE AGREEMENT BY AND BETWEEN THE CITY OF TRENTON, MISSOURI, AND HATTESOHL & ASSOCIATES LAND SURVEYING, LLC FOR LARGE FORMAT COLOR PRINTER SERVICES AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY, which was read. Motion by Councilmember Brewer second by Councilmember Mlika that Bill No. 34 be passed to the second reading placed upon final passage and voted on. Discussion was held. Motion carried. A copy of Bill No. 34 was made available for public inspection prior to this meeting by being posted at City Hall on August 5, 2022. The following vote was taken. UNFINISHED BUSINESS

Discussion was held concerning Serendipity Lane. City Administrator Urton said surrounding landowners purchased the property that Mr. Webb was going to put houses on. Snow removal will be the same as always.

City Councilmember Brewer asked that the street department look at the shoulders and road north of the old Jim's Building Supply on Oklahoma Avenue. They said it is holding water.

NEW BUSINESS

City Administrator Urton said we received 2 bids for asbestos removal. The low bid was from Enviro Solutions for \$4,325.00. Motion by Councilmember Mlika second by Councilmember Briggs to accept the low bid from Enviro Solutions for \$4,325.00 for asbestos removal. Motion carried.

The 2022-2023 demolition list was discussed. Motion by Councilmember Briggs second by Councilmember Mlika to accept the list including 208 E. 10th Ct. Motion carried.

City Administrator Urton said it was discussed at the last meeting about putting the 2 old police cars on purple wave. Someone came up with the idea of putting them out at the airport and to sell the van and jeep on purple wave. Motion by Councilmember Briggs second by Councilmember Otto to sell the van and jeep on purple wave and put the 2 old police cars at the airport. Motion carried.

Discussion was held concerning the Dollar General street lighting. The cost will be \$15,000 for the break away poles and \$5,000 for the time for our employees to put them up. It was decided since it is not budgeted to move this to the utility committee.

City Administrator Urton said the state bid for a UTV for the water plant is \$18,646.97. Motion by Councilmember Briggs second by Councilmember Brewer to buy the UTV from LSK Lebanon, Inc. and buy a spray tank to put on it to spray weeds. Motion carried.

Motion by Councilmember Brewer second by Councilmember Briggs meeting adjourned at 7:50 p.m. Motion carried.
