BILLS

REPORTS

Mayor Crooks recognized Police Officer Michael Williams, who was present, and Police Officer Zach Underwood, who was not present, for saving the life of a detention officer.

Councilmember Otto said the police personnel board met on September 10th and the board would like to ask the council to hire Carly Taul as a police officer contingent upon her passing the academy in December. Motion by Councilmember Briggs second by Councilmember Mlika to hire Carly Taul when she passes the academy in December. Motion carried.

City Administrator Urton said the streetlights are in the works going down to Dollar General and repairs will be made on Oklahoma Ave for the water standing on the roadway.
