MINUTES

Motion by Councilmember Brewer second by Councilmember Briggs that the minutes of September 12, 2022, be approved. Motion carried.

BILLS

Motion by Councilmember Brewer second by Councilmember Briggs that all duly obligated bills for the city be paid. Motion carried.

REPORTS

Reports were given by Councilmember Mlika, Councilmember Brewer and City Administrator Urton passed out his report.

BILL NO. 40

Motion by Councilmember Brewer second by Councilmember Briggs that Bill No. 40 be introduced, AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING AN ENGINEERING WORK ORDER BY AND BETWEEN THE CITY OF TRENTON, MISSOURI AND HOWE COMPANY, LLC FOR A FACILITY PLAN FOR THE INSTALLATION OF SANITARY SEWER MAINS THAT DRAIN TO PAUPER GRADE AND PLEASANT PLAINS LIFT STATIONS BETWEEN THE CITY OF TRENTON AND HOWE COMPANY, LLC IN THE CITY OF TRENTON AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY, which was read. Motion by Councilmember Brewer second by Councilmember Briggs that Bill No. 40 be passed to the second reading placed upon final passage and voted on. Discussion was held. Motion carried. Motion by Councilmember Brewer second by Councilmember Briggs that bill No. 41 be introduced, AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING AN ENGINEERING WORK ORDER BY AND BETWEEN THE CITY OF TRENTON, MISSOURI AND HOWE COMPANY, LLC FOR A FACILITY PLAN FOR THE REPLACEMENT OF WATER MAINS BETWEEN THE CITY OF TRENTON AND HOWE COMPANY, LLC IN THE CITY OF TRENTON AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY, which was read. Motion by Councilmember Brewer second by Councilmember Briggs that Bill No. 41 be passed to the second reading placed upon final passage and voted on. Motion carried. NEW BUSINESS

Discussion was held concerning the dangerous dog ordinance. City Attorney Walker said this incident is in criminal court so the judge will decide what happens to the dog.

Motion by Councilmember Brewer second by Councilmember Mlika to take the dangerous dog ordinance to the administrative committee. Motion carried.

City Administrator Urton presented the new personnel policy and went over the changes. The changes were the PTO calculated with years of service, PTO donation attachment, removed the credit union membership, MML update for years of service and the drug free workplace update.

Motion by Councilmember Briggs second by Councilmember Mlika to accept the changes to the personnel manual. Motion carried.

Discussion was held concerning Change Order No. 1 for sewer lining from 16th street down to Muddy Creek main. This will be paid for with the ARPA funds.

Motion by Councilmember Mlika second by Councilmember Briggs to accept Change Order No. 1 for sewer lining. Motion carried.
