BILLS

Motion by Councilmember Briggs second by Councilmember Brewer that all duly obligated bills for the city be paid. Motion carried.

REPORTS

Mayor Crooks congratulated Colton Roy on being the State President for FFA.

BILL NO. 13

Motion by Councilmember Brewer second by Councilmember Briggs that Bill No. 13 be introduced, AN ORDINANCE AMENDING SECTION 340.110 ENTITLED "ALL-TERRAIN VEHICLES, PROHIBITED—EXCEPTIONS, OPERATION OF UNDER AN EXCEPTION—PROHIBITED USES—PENALTY" OF CHAPTER 340 ENTITLED "MISCELLANEOUS DRIVING RULES" OF TITLE III ENTITLED "TRAFFIC CODE" OF THE TRENTON CITY CODE, which was read. Motion by Councilmember Brewer second by Councilmember Briggs that Bill No. 13 be passed to the second reading placed upon final passage and voted on. Motion carried. BILL NO. 14

Motion by Councilmember Brewer second by Councilmember Mlika that Bill No. 14 be introduced, AN ORDINANCE AMENDING SECTION 340.115 ENTITLED "OPERATION OF UTILITY VEHICLES, WHEN—OPERATION IN WATERWAYS, WHEN—LICENSE REQUIRED—PASSENGERS—VIOLATIONS, PENALTIES" OF CHAPTER 340 ENTITLED "MISCELLANEOUS DRIVING RULES" OF TITLE III ENTITLED "TRAFFIC CODE" OF THE TRENTON CITY CODE, which was read. Motion by Councilmember Brewer second by Councilmember Briggs that Bill No. 14 be passed to the second reading placed upon final passage and voted on. Motion carried. A copy of Bill No. 14 was made available for public inspection prior to this meeting by being posted at City Hall on April 22, 2022. The following vote was taken. Said bill was declared duly passed, numbered Ordinance No. 2022-14, signed and approved by the Mayor and attested by the City Clerk.

NEW BUSINESS

Craig Woycheese with Toth presented a water and wastewater department cost of services studies. Toth is proposing a 6.5% increase in water and 3% increase in wastewater. Ron said everyone should look over this study and we will discuss it at the next Utility Board meeting.

City Administrator Urton would like to change the ordinance for utility committee appointments. He would recommend making this an advisory board with 4 councilmembers on it. The change would not take effect until next April election. Motion by Councilmember Briggs second by Councilmember Mlika to have Tara change the ordinance and bring it back to the council. Motion carried.

Discussion was held concerning purchasing a pump for clarifier #1. The pump would be from JCI for \$13,445.00. This was not budgeted. Discussion for new lift station pumps from Enviro-line Co for 5 pumps for a total of \$36,257.00 which does not include installation, freight, startup or any taxes that may apply. These are budgeted items. Motion by Councilmember Brewer second by Councilmember Mlika to purchase the pumps. Motion carried.

City Administrator Urton said the sewer plant had budgeted a truck last year but did not purchase it because of the 6-month lead time. They have a quote from Don Brown Chevrolet, the state bid, for \$35,174.00. Motion by Councilmember Briggs second by Councilmember Brewer to purchase the pickup from Don Brown Chevrolet for \$35,174.00. Motion carried.
