The Mayor and City Council met in open session, Monday, January 9, 2023, at 7:00 p.m. at city hall. The following officers and members were present: Mayor Linda Crooks; Council members Glen Briggs-via video conferencing, Danny Brewer, Marvin Humphreys, Robert Romesburg, David Mlika, Duane Urich and John Dolan-via audio conferencing; City Attorney, Tara Walker; City Administrator, Ron Urton; Police Chief, Rex Ross and City Clerk, Cindy Simpson.

PLEDGE OF ALLEGIANCE AND PRAYER

At this time, the Pledge of Allegiance was recited. A prayer followed the pledge.

MINUTES

Motion by Councilmember Brewer second by Councilmember Mlika that the minutes of December 12, 2022, be approved. Motion carried.

BILLS

Motion by Councilmember Brewer second by Councilmember Mlika that all duly obligated bills for the city be paid. Motion carried.

REPORTS

Reports were given by City Clerk Simpson; Councilmember Romesburg and City Administrator Urton.

BILL NO. 1

Motion by Councilmember Brewer second by Councilmember Mlika that Bill No. 1 be introduced, AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING A CONTRACT BY AND BETWEEN THE CITY OF TRENTON, MISSOURI AND HOSTETLER TRUCKING., FOR THE HAULING OF SAND FOR THE CITY OF TRENTON AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY, which was read. Motion by Councilmember Brewer second by Councilmember Mlika that Bill No. 1 be passed to the second reading placed upon final passage and voted on. Motion carried. A copy of Bill No. 1 was made available for public inspection prior to this meeting by being posted at city hall on January 6, 2023. The following vote was taken. Ayes: Briggs, Brewer, Humphreys, Romesburg, Mlika, Urich and Dolan. Said bill was declared duly passed, numbered Ordinance No. 2023-1, signed and approved by the Mayor and attested by the City Clerk.

BILL NO. 2

Motion by Councilmember Brewer second by Councilmember Romesburg that Bill No. 2 be introduced, AN ORDINANCE AMENDING SECTION 210.200 ENTITLED "OWNING, KEEPING OR HARBORING OF DANGEROUS DOGS" OF ARTICLE II ENTITLED "DOGS AND CATS" OF CHAPTER 210 ENTITLED "ANIMALS AND FOUL" OF TITLE II ENTITLED "PUBLIC HEALTH, WELFARE AND SAFETY" OF THE TRENTON CITY CODE, which was read. Motion by Councilmember Brewer second by Councilmember Romesburg that Bill No. 2 be passed to the second reading placed upon final passage and voted on. Discussion was held. Motion carried. A copy of Bill No. 2 was made available for public inspection prior to this meeting by being posted at city hall on January 6, 2023. The following vote was taken. Ayes: Briggs, Brewer, Humphreys, Romesburg, Mlika, Urich and Dolan. Said bill was declared duly passed, numbered Ordinance No. 2023-2, signed and approved by the Mayor and attested by the City Clerk.

NEW BUSINESS

Mayor Crooks said she would like to appoint Jim Norris, Micah Landes and Debbie Carmen to the Convention and Visitors Board. Motion by Councilmember Mlika second by Councilmember Urich to accept the Mayor's appointments of Jim Norris, Micah Landes and Debbie Carmen to the Convention and Visitors Board. Motion carried.

City Administrator Urton said we received 2 bids for the water treatment plant clarifier modification. The low bid was from Irvinbilt Constructors, Inc. We also would like to add Alternate #1 which would make the bid \$1,768,339.00. Motion by Councilmember Urich second by Councilmember Mlika to accept the bid from Irvinbilt Constructors, Inc. for the base bid and the Alternate 1. Motion carried.

City Administrator Urton said the Park department is purchasing 2 new mower and will have 2 mowers to sell. We would like to purchase 1 of the mowers for the airport and sell 1 mower that this replaces at the airport. Motion by Councilmember Romesburg second by Councilmember Mlika to purchase 1 used mower from the park department for the airport and sell 1 mower at the airport. Motion carried.

City Administrator Urton said we have some surplus property to sell on purple wave and would like to sell the 2011 Chevrolet Impala. He would also like to let people use their personal vehicles to go on out of town trips and get paid the IRS mileage.

Discussion was held concerning the TMU warehouse building to store equipment inside. Motion by Councilmember Urich second by Councilmember Romesburg to bid out the building. Motion carried.

Discussion was held concerning 10th & Oklahoma Avenue water main project. This will be done in 2 or 3 phases.

Discussion was held about the request from North Central Missouri Rural Water Commission for the base rate to be dropped since they are not using that line. Motion by Councilmember Mlika second by Councilmember Urich to suspend the base rate until they decide to use the line again. Motion carried.

City Administrator Urton discussed the ARPA grant at the airport. He said we applied for \$295,000 but only are receiving \$22,000. This will be used to purchase fuel.

Motion by Councilmember Brewer second by Councilmember Mlika meeting adjourned at 7:46 p.m. Motion carried.
