Motion by Councilmember Brewer second by Councilmember Humphreys that Bill No. 12 be introduced, AN ORDINANCE AMENDING SECTION 220.020 ENTITLED "DEBRIS ON PROPERTY- EFFECT OF FAILURE TO REMOVE NUISANCE-- PENALTIES" OF ARTICLE II ENTITLED "WEEDS, HIGH GRASS AND OTHER VEGETATION" OF CHAPTER 220 ENTITLED "NUISANCES" OF TITLE II ENTITLED "PUBLIC HEALTH, WELFARE AND SAFETY" OF THE TRENTON CITY CODE, which was read. Motion by Councilmember Brewer second by Councilmember Urich that Bill No. 12 be passed to the second reading placed upon final passage and voted on. Discussion was held. Motion carried. Motion by Councilmember Brewer second by Councilmember Humphreys that Bill No. 13 be introduced, AN ORDINANCE DECLARING THE RESULTS OF THE GENERAL ELECTION HELD IN THE CITY OF TRENTON, MISSOURI, ON APRIL 4, 2023, FOR THE ELECTION OF A MAYOR FOR A REGULAR TERM OF FOUR YEARS AND ONE CITY COUNCILMAN FROM EACH OF THE FOUR WARDS OF THE CITY OF TRENTON, MISSOURI, FOR A REGULAR TERM OF TWO YEARS AND THE QUESTION: SHALL THE CITY OF TRENTON, MISSOURI IMPOSE A 3% SALES TAX LEVY ON RETAIL SALES OF ADULT USE MARIJUANA SOLD IN TRENTON, MISSOURI, which was read. Motion by Councilmember Brewer second by Councilmember Urich that Bill No. 13 be passed to the second reading placed upon final passage and voted on. Motion carried.
