The Mayor and City Council met in open session, Monday, May 8, 2023, at 7:00 p.m. at city hall. The following officers and members were present: Mayor Jackie Soptic; Council members William Fisher, Glen Briggs, Calvin Brown, Marvin Humphreys, Timothy Meinecke, David Mlika and Duane Urich; City Attorney, Tara Walker; City Administrator, Ron Urton; Police Chief, Rex Ross and City Clerk, Cindy Simpson. Absent: Councilmember John Dolan.

## MINUTES

Motion by Councilmember Mlika second by Councilmember Briggs that the minutes of April 24, 2023, be approved. Motion carried.

## BILLS

Motion by Councilmember Mlika second by Councilmember Briggs that all duly obligated bills for the city be paid. Motion carried.

## REPORTS

Reports were given by Councilmember Briggs, and Councilmember Humphreys.

The Utility Committee meeting was set for May 16, 2023 at 6:00 p.m.

Police Chief Ross gave a report on meetings with the Green Hills Animal Shelter and the Josh Gottman family concerning mowing and cleanup.

## BILL NO. 14

Motion by Councilmember Humphreys second by Councilmember Briggs that Bill No. 14 be introduced, AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING AN AGREEMENT BY AND BETWEEN THE CITY OF TRENTON, MISSOURI, AND AIRPORT IFE SERVICES, INC FOR THE COMPLETION OF TRENTON MUNICIPAL AIRPORT'S CONSTRUCT T-HANGAR AND RAMP IFE AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY, which was read. Motion by Councilmember Humphreys second by Councilmember Briggs that Bill No. 14 be passed to the second reading placed upon final passage and voted on. Discussion was held. Motion carried. A copy of Bill No. 14 was made available for public inspection prior to this meeting by being posted at City Hall on May 5, 2023. The following vote was taken. Ayes: Fisher, Briggs, Brown, Humphreys, Meinecke, Mlika and Urich. Absent: Dolan. Said bill was declared duly passed, numbered Ordinance No. 2023-14, signed and approved by the Mayor and attested by the City Clerk.

NEW BUSINESS

The city only received 2 bids for the demolition project. Motion by Councilmember Mlika second by Councilmember Humphreys to hire Perkins Dozing as the contractor for the demolition project. Motion carried with Councilmember Briggs voting no.

Motion by Councilmember Mlika second by Councilmember Briggs to hire Red Rock for the hazardous material inspections for the demolition project. Motion carried.

Discussion was held concerning a quote for an Aerial bucket truck for the electric department. Motion by Councilmember Briggs second by Councilmember Mlika to go ahead and order the truck since it takes so long to get it. Motion carried.

Discussion was held concerning 3 quotes we got from Mid-Continental Restoration Co. for repairs to the city hall building. The first quote was \$55,000 to do all the work. The second phase 1 quote was for \$21,000 and phase 2 was for \$40,000. City Administrator Urton said we did not budget the repairs for this year, but the work needs to be done because we are getting water in the basement. Motion by Councilmember Brown second by Councilmember Briggs to do the whole project this year. Motion carried.

Discussion was held when to have utility committee meetings and administrative meetings. The utility committee will meet on the third Tuesday of each month and the administrative committee will meet on May 18 at 5:00.

City Administrator Urton reported at the last closed session meeting the city purchased property at 1013 Tindall Avenue for \$2500.00.

Motion by Councilmember Briggs second by Councilmember Brown meeting adjourned at 7:59 p.m. Motion carried.
