Rates above do not include the Missouri DNR Drinking Water Primacy. This fee is assessed by DNR annually and charged to customers as a separate line item on the utility bill.

Sales tax on water is as follows: Residential -3%, Residential outside city limits -1.5%, Commercial -8.35%, Commercial outside city limits -5.725% 100% Manufacturing tax - exempt from taxes.

Effective Date of New Rates

The new waters rates established herein shall become effective with usage beginning May 1st, 2023, and on bills posted on or after May 31st, 2023
