

Trenton, Missouri
June 26, 2023

The Mayor and City Council met in open session, Monday, June 26, 2023, at 7:00 p.m. at City Hall. The following officers and members were present: Mayor Jackie Soptic; Council members William Fisher, Glen Briggs, Calvin Brown, Marvin Humphreys, Timothy Meinecke, David Mlika and John Dolan; City Attorney, Tara Walker; City Administrator, Ron Urton; Police Chief, Rex Ross and City Clerk, Cindy Simpson. Absent: Councilmember Duane Urich.

MINUTES

Motion by Councilmember Briggs second by Councilmember Fisher that the minutes of June 12, 2023, be approved. Motion carried.

BILLS

Motion by Councilmember Briggs second by Councilmember Brown that all duly obligated bills for the city be paid. Motion carried.

REPORTS

Reports were given by Councilmember Briggs, Code Enforcement Officer Barone and City Administrator Urton.

City Administrator Urton said the rock quarry has 3,000 ton excess asphalt rock. They want to know if we would like to purchase it. Motion by Councilmember Briggs second by Councilmember Mlika to buy the excess 3,000 ton of asphalt rock. Motion carried.

City Administrator Urton said Maple Grove Cemetery wants the city to pave their driving path. They will pay us for this.
