### MINUTES

### BILL NO. 40

Motion by Councilmember Briggs second by Councilmember Urich that Bill No. 40 be introduced, AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING AN AGREEMENT BY AND BETWEEN THE CITY OF TRENTON, MISSOURI, AND R/S ELECTRIC CORP FOR RELOCATION OF ELECTRICAL EQUIPMENT AT THE RIVER PUMP STATION AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY, which was read. Motion by Councilmember Briggs second by Councilmember Urich that Bill No. 40 be passed to the second reading placed upon final passage and voted on. Discussion was held. Motion carried. A copy of Bill No. 40 was made available for public inspection prior to this meeting by being posted at city hall on July 21, 2023. The following vote was taken. ### BILL NO. 41

Motion by Councilmember Briggs second by Councilmember Urich that Bill No. 41 be introduced, AN ORDINANCE OF THE CITY OF TRENTON, MISSOURI APPROVING

AN ENGINEERING WORK ORDER BY AND BETWEEN THE CITY OF TRENTON, MISSOURI AND HOWE COMPANY, LLC FOR THE PREPARATION OF AN APPLICATION FOR A TAP GRANT BETWEEN THE CITY OF TRENTON AND HOWE COMPANY, LLC IN THE CITY OF TRENTON AND AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF TRENTON, MISSOURI, TO EXECUTE THE SAME BY AND ON BEHALF OF SAID CITY, which was read. Motion by Councilmember Briggs second by Councilmember Urich that Bill No. 41 be passed to the second reading placed upon final passage and voted on. Discussion was held. Motion carried.
