MINUTES

Motion by Councilmember Mlika second by Councilmember Briggs that the minutes of June 26, 2023, be approved. Motion carried.

BILLS

Motion by Councilmember Briggs second by Councilmember Mlika that all duly obligated bills for the city be paid. Motion carried.

REPORTS

Reports were given by Councilmember Briggs concerning the city website; Councilmember Mlika wants the fireworks day and times for shooting to be looked at the administrative committee; City Administrator Urton went over his report; Mayor Soptic reported on items. Mayor Soptic asked the council to think about changing the time of the council meeting to 6:00 p.m. We will need an ordinance to change the time.

PUBLIC COMMENT

Mayor Soptic would like to reappoint Gary Hooyman to the airport board. Motion by Councilmember Briggs second by Councilmember Mlika to approve the Mayor's appointment. Motion carried.

Christopher Jones is wanting to purchase the property at 1415 Lulu that the City has put a lien on, so he has filed a lien reduction application. The price he would pay the city would be \$500.00. Motion by Councilmember Briggs second by Councilmember Fisher to allow Christopher Jones to pay the City \$500.00 for the lien reduction contingent on him buying the property at 1415 Lulu. Motion carried.

Councilmember Humphreys would like to see the brush dump be kept open on Saturdays so people that work can take their brush out there. The fire department can open and close the gates on Saturday. It would be the regular hours as Monday thru Friday. Motion by Councilmember Humphreys second by Councilmember Fisher to keep the brush dump open on Saturday. Motion carried. Councilmember Briggs voted no.

Motion by Councilmember Briggs second by Councilmember Urich to send the ordinance for prohibiting the selling of dogs on the streets to the administrative committee. Motion carried.

Motion by Councilmember Briggs second by Councilmember Urich meeting adjourned at 7:56 p.m. Motion carried.
