MINUTES

Motion by Councilmember Briggs second by Councilmember Fisher that the minutes of August 14, 2023, be approved. Motion carried.

BILLS

Motion by Councilmember Briggs second by Councilmember Fisher that all duly obligated bills for the city be paid. Motion carried.

REPORTS

Reports were given by Councilmember Brown concerning the concrete bids at the last meeting.

Councilmember Mlika reported on the Building and Nuisance Board meeting.

Councilmember Urich reported on the ED meeting and the possibility of the fair board moving. He also reported on the utility committee.

Mayor Soptic passed out her report.

City Administrator Urton went over some of his report. He also said the city received 2 bids for trash and 1 for recycling. One of the trash bids was not complete. Do you want to consider the 2nd bid or just the one that is complete. It was the consensus of the council to not consider any incomplete bids.

PUBLIC HEARING

City Clerk Cindy Simpson said the proposed tax levy is \$1.000 for general fund and \$.1886 for Park. This is just a little increase from last year but the assessed value also went down.

<u>UNFINISHED BUSINESS</u>

Councilmember Briggs said if we get the grant for the sidewalk we will be spending \$175,000. He feels we should have a fund to replace the sidewalks when they wear out. More discussion will be held on this if we get the grant.

NEW BUSINESS

Discussion was held concerning the 2023 asbestos abatement removal bids. The low bid was 24/7 Enviro Solutions, who had it last year. Motion by Councilmember Briggs second by Councilmember Fisher to accept the low bid from 24/7 Enviro Solutions for \$14,937.50. Motion carried.

Discussion was held concerning the demolition project cost for 1013 Tindall. The city of Trenton owns this because a sewer line runs under the house. TMU bought it and will be paying the demolition cost of \$8,500.00. Motion by Councilmember Humphreys second by Councilmember Briggs to approve the demolition cost for 1013 Tindall Avenue for \$8,500.00. Motion carried.

Discussion was held concerning the 23-24 demolition list. Motion by Councilmember Humphreys second by Councilmember Fisher to approve the list with 835 W. 13th court and 416 W. 13th Ct. taken off the list. The following vote was taken. Ayes: Urich, Fisher, Brown, Humphrey and Meinecke. Naye: Mlika, Dolan and Briggs. Motion carried.

Mayor Soptic said we need to develop a demolition policy so she is moving that to the Administrative Committee.

Motion by Councilmember Briggs second by Councilmember Mlika meeting adjourned at 8:10 p.m. Motion carried.
