# **REPORTS**

Councilmember Briggs reported on the electronic waste collection that was held on Friday and Saturday.

Councilmember Briggs said the police personnel board met and would like to hire Anthony May pending his graduation in December. Motion by Councilmember Urich second by Councilmember Dolan to hire Anthony May as a police officer pending his graduation. Motion carried.

Councilmember Urich reported on the utility committee meeting and the economic development committee meeting.

Councilmember Mlika reported on the building and nuisance board meeting. Three properties have been cleaned up.

City Administrator Urton gave his report. Urton passed out an equipment estimate from Vermeer for a vacuum excavator for Kenny's crew. The budget was \$75,000 and the price was \$75,150.00. No bids were taken. Motion by Councilmember Brown second by Councilmember Fisher to purchase the equipment. Motion carried with Councilmember Humphreys voting no.

City Administrator Urton said bids were taken for the river pump station improvements. The engineering company is recommending the bid from Smico Contracting Group for \$183,912.00.

Motion by Councilmember Urich second by Councilmember Fisher to accept the bid from Smico Contracting Group for \$183,912.00 for the river pump station improvements. Motion carried.

Councilmember Urich said he asked for the demolition list to be brought back to the Council. He feels we should put the 2 properties that were taken off the list back on.

Discussion was held.

Motion by Councilmember Mlika second by Councilmember Dolan to put back on the demolition list 835 W. 13<sup>th</sup> Ct. and 416 W. 13 Ct. The following vote was taken. Ayes: Briggs, Mlika, Urich and Dolan. Naye: Fisher, Brown, Humphreys and Meinecke. Mayor Soptic voted Aye.
