MINUTES

Motion by Councilmember Mlika second by Councilmember Meinecke that the minutes of January 13, 2025, be approved. Motion carried.

BILLS

Motion by Councilmember Mlika second by Councilmember Dolan that all duly obligated bills for the city be paid. Motion carried.

REPORTS

Councilmember Humphreys reported on the utility committee meeting held January 21. City Administrator Urton thanked Code Enforcement Officer Wes Barone for clearing the snow at City Hall. He gave updates on the clarifier and sewer linings.

Motion by Councilmember Meinecke second by Councilmember Mlika that Bill No. 5 be passed to the second reading placed upon final passage and voted on. Discussion was held. Motion carried. Mayor Soptic recommended Jason Shuler be appointed to serve on the Police Personnel Board. Motion by Councilmember Mlika second by Councilmember Dolan that the recommendation of Mayor Soptic to the Police Personnel Board be approved. Motion carried.

Motion by Councilmember Urich second by Councilmember Dolan meeting adjourned at 7:12 p.m. Motion carried.
