#### MINUTES

## PUBLIC COMMENT

Fire Chief Brandon Gibler recognized three high school seniors who have been a part of the cadet firefighter program. Christy Gibler is the coordinator of the program.

Mayor Soptic recognized the NCMC Pirate and Lady Pirate basketball teams, along with coaches Jeremy Esry and Jenni Croy, for their achievements during the 2024-25 season.

#### REPORTS

Councilmember Mlika mentioned he had had a request from the college for the city to partner with them to put in a sidewalk behind the museum. Mayor Soptic made the recommendation to have City Administrator Urton and Code Enforcement Officer Barone meet with the college to see what they are needing.

Councilmember Humphreys reported on the recent Convention and Visitors Bureau meeting. He said they are keeping the website up to date, working with City Administrator Urton on the wayfinding signs, and working to establish mini grants.

Councilmember Briggs reported he met recently with City Administrator Urton and Mayor Soptic about possible funding opportunities. He also thanked MoDOT for painting the lines at the 9<sup>th</sup> & Main stop light.

Motion by Councilmember Briggs second by Councilmember Urich that Bill No. 24 be passed to the second reading placed upon final passage and voted on. Discussion was held. Motion carried. #### **NEW BUSINESS**

Discussion was held on mowing bids received for the 2025 mowing season. Code Enforcement Officer Barone said there were five bids received. Motion by Councilmember Briggs second by Councilmember Mlika to accept the bid from Lawn Legends-Thane Denney of \$170.00 per mowing for the cemetery and \$200.00 per mowing for the city lots. Motion carried.

Discussion was held on the emergency nuisance abatement bids received for the 2025 year. Code Enforcement Officer Barone said there were two bids received:

Bond Yard Service – \$50 per hour for total job, including tall grass, weed eating and cutting, removing brush.

Lawn Legends-Thane Denney – tall grass, \$75 per hour; weed eating, etc, \$55 per hour; cutting, removing brush - \$55 per hour.

Motion by Councilmember Brown second by Councilmember Mlika to accept both bids as received. Motion carried, with Councilmember Briggs voting no.
